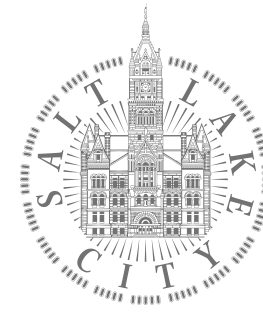

Salt Lake City's commitment to renewable energy has accelerated in the last year. The Clean Energy Cooperative Agreement, signed last August, is a joint statement to affirm that Rocky Mountain Power (RMP) and the City will collaboratively work toward achieving explicit sustainability goals. A requirement of the franchise agreement (binding) is an annual report updating the City on progress, anticipated next steps and other considerations. Under this approach, the City and RMP will collaborate on increasing the supply of renewable energy in the Salt Lake City market. This enables us to reevaluate our progress toward the City's sustainability goals and reflect our pathway to achieve that in subsequent contracts. Learn more at www.SLCgreen.com/climatepositive.

Dear Neighbors,

There is much to share since our last annual newsletter. We made incredible progress on our City's energy efficiency goals, started important work on and around State Street, committed \$21 million for affordable housing, and are ready for the grand opening of the McClelland Trail.

The homeless resource center at 275 High Avenue in our district is moving forward and we need to hear from you. The Council will soon consider standards for homeless resource centers in order to minimize negative impacts on the surrounding community. The Council is also considering ways to give neighborhoods some oversight of the new facilities.

The State Street area is under an unprecedented spotlight with increased police patrols, neighborhood engagement, and development and visioning projects currently in progress.

In 2016, the City revised the Community Business (CB) zoning district to require more scrutiny of requests for increased building height, decreased parking, and other potential deviations from the neighborhood's character. This will help ensure that development in our area grows in keeping with the 9th & 9th and other Small Area Plans.

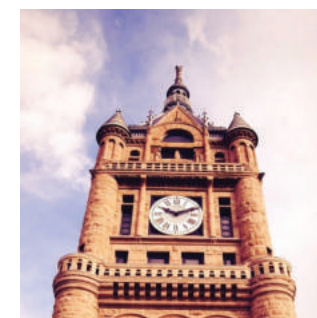

THE FUTURE OF STATE STREET

At the Council's annual priority workshop in January, we discussed ways to improve quality of life in the State Street area. In recent months, State Street has been recognized as a valuable asset by City, County, State and national entities. Parts of State Street are included in Salt Lake City's "Main Street America" designation, which gives support focused on community revitalization and preservation-based economic development. Read about this tool at www.MainStreet.org. Additionally, a new coalition has formed of business owners, community members, and education partners in the State Street area. The State Street Coalition meets regularly to provide input and advocacy on issues affecting economic health, connectivity and quality of life.

Life on State Implementation Plan

The *Life on State Implementation Plan* will study roadway realignments and development opportunities for the State Street corridor with the goal of making State Street a model for sustainable street design, urban design and planning for the region and Utah. It will build on the 2020 *Life on State Vision* that imagined State Street as Utah's "great street" from the Capitol to Draper. The plan will deliver clear, actionable strategies that promote economic development, improve transportation options, address safety and security along the corridor, and celebrate our social and civic experience. Redevelopment State Street Project Area

The Redevelopment Agency (RDA) utilizes tax increment from a specific area of the City called a project area to fund urban renewal projects and programs within that same area. Businesses and residents within RDA project areas benefit from access to the RDA's programs and from the private investment spurred by RDA activities.

RDA Board Members received multiple briefings on a proposed State Street project area, and are currently reviewing the plan to ensure that vital blocks in this area are included for redevelopment benefits over the next 25 years. Project area tools include the Revolving Loan Program, Tax Increment Reimbursement Program, and infrastructure improvements. Learn more at www.slcrda.com/projectareas.htm.



NEIGHBORHOOD CLEANUP PROGRAM

Each year, Salt Lake City residents can dispose of bulky waste through the Neighborhood Cleanup Program. From April to October, waste & recycling crews move through the City one neighborhood at a time collecting waste. You will receive a postcard in the mail approximately three weeks before your cleanup date. To ensure items are disposed of properly, please observe these guidelines:

Instructions for Your Pile:

- ✓ Examples of appropriate items include: old furniture, mattresses, large tree limbs, etc.
- ✓ Separate green waste from other items in your pile. Do not bag. Green waste is composted.
- ✓ Separate mattresses from other items in your pile. These are recycled.
- ✓ Make sure your pile does not block traffic, bike lanes, fire hydrants, storm drains or sidewalks.
- ✓ Heavy materials (rocks, sod, concrete, asphalt) must not exceed two wheelbarrows full.
- ✓ Cardboard boxes should not be placed on the curb, but recycled in your curbside bin.
- ✓ Clothing should be donated to your local thrift store.
- ✓ Residents are encouraged to donate books instead of throwing them away. Recycle paperback books in your curbside bin.

Items NOT Eligible for Pickup:

- ✗ Commercial construction waste – contractors are not allowed to participate in this program. More information on disposing of this type of waste is available at www.SLCgreen.com.
- ✗ Electronics, tires or household hazardous waste (fluorescent lights, paint, oil, TVs, batteries, computers, chemicals, pesticides). These materials can damage our community by seeping into groundwater and poisoning the environment.
- ✗ Flammable/explosive material (aerosol cans, propane tanks, etc.). Call your local fire station for disposal information.

Other Information:

- Failure to comply may result in a citation/\$50 minimum penalty.
- Report illegal dumping at 385-468-3862. Document license plate number, color & make of vehicle.

JOIN SLCPD'S VOLUNTEER CORPS



Community Supported Policing acknowledges that the whole community is responsible for public safety, not just the police. This approach encourages the unification of the community and the police in an equal partnership, working together through effective problem solving. In Salt Lake City, the SLCPD Volunteer Corps is an approach that holds tremendous promise for empowering residents to work with the police to effectively combat crime problems in the community together.

SLCPD Volunteer Corps members are regular residents like you who are trained and authorized to patrol every part of the City. In order to provide a reduction in liability problems and to ensure a viable organization, all applicants must pass a background investigation and attend training.

Residents around Liberty Park recently met with SLCPD to organize a more localized iteration of the citywide Volunteer Corps. Watch for information at the park and connect with the community around this at "Liberty Park Watch" on Facebook to learn more.
