SALT LAKE CITY – Re-elected City Council Members James Rogers and Erin Mendenhall, and two new Council Members, Chris Wharton and Amy Fowler, will be sworn into office at noon on Tuesday, Jan. 2, 2018 at the Salt Lake City & County Building, 451 South State Street.

The oath of office Ceremony will be held outside on the east steps of the City & County Building. The Salt Lake City Fire Department Choir, the Salt Lake City Police Motor Squad, and Young Eagles Rugby are scheduled to take part in the program.
